LIABILITY WAIVER, ASSUMPTION OF RISK & CONSENT AGREEMENT

1. ACKNOWLEDGMENT OF NATURE OF SESSION

Client understands that this studio photography session may include:

- Partially clothed or body-focused posing
- Application of body oil to enhance skin appearance
- Physically demanding or guided posing
- Use of furniture, props, or elevated surfaces
- Floor work, arching, stretching, kneeling, balancing, or shifting body weight

Client acknowledges that:

- Body oil may make skin and surfaces slippery
- Posing on props, furniture, or elevated surfaces may create a risk of falling
- Holding poses or restricting breathing may cause dizziness or lightheadedness
- Arriving without proper hydration or nutrition may increase fainting risk
- Certain poses may require flexibility, balance, strength, or maintaining positions for extended periods

2. VOLUNTARY PARTICIPATION & ASSUMPTION OF RISK

Client voluntarily agrees to participate and assumes all risks associated with this session, including but not limited to:

- Slipping due to oil on skin or surfaces
- Falling from props, furniture, or elevated surfaces
- Loss of balance while posing or wearing heels
- Muscle strain or joint stress
- Nerve compression caused by positioning
- Bruising or minor physical injury
- Dizziness, fainting, or temporary loss of consciousness
- Accidental contact with studio equipment, furniture, or fixtures

Client understands that photography sessions may take place in third-party rental studios. While Photographer takes reasonable precautions regarding safety, Photographer does not control or warrant the condition, maintenance, or operation of facilities owned or operated by third parties.

3. BODY OIL APPLICATION & PROFESSIONAL CONTACT CONSENT

Client consents to:

- Application of body oil for artistic purposes
- Verbal direction and guided posing
- Light physical adjustments by Photographer when necessary to achieve proper posing

Client acknowledges that all contact is professional in nature and not sexual or inappropriate.

4. HEALTH DISCLOSURE

Client confirms they are physically able to participate in this session.

Client agrees to inform Photographer prior to the session if they are pregnant or believe they may be pregnant. If pregnant, Client confirms they have consulted with a medical professional and feel comfortable participating.

Photographer is not a medical professional and is not responsible for undisclosed health conditions.

Photographer is not responsible for injuries, fainting, dizziness, medical events, or adverse physical reactions resulting from dehydration, inadequate nutrition, undisclosed medical conditions, physical overexertion, or Client's failure to follow safety guidance.

5. IMPAIRMENT & INTOXICATION

Client acknowledges that participation while under the influence of alcohol, recreational drugs, prescription medication affecting coordination or awareness, or any substance that may impair balance, judgment, reaction time, or physical stability significantly increases the risk of injury.

Client assumes full responsibility for participation while impaired.

Client agrees that Photographer is not responsible for injuries, accidents, or adverse outcomes resulting from Client's impairment.

Photographer reserves the right to discontinue the session if impairment is observed.

6. BEHIND-THE-SCENES (BTS) VIDEO SERVICE

If BTS service is added:

- BTS filming is performed by Sergei Fadeev
- Sergei may be present in the studio during the session
- Client consents to an additional adult male being present for filming purposes
- Client may decline this service if uncomfortable

7. STUDIO WARDROBE & SANITATION

Client acknowledges that:

- Photographer may provide studio wardrobe or styling pieces
- All wardrobe items are washed and sanitized after each use

- Items may have been previously worn or tried on by other clients, but are properly cleaned and safe for use

8. EMERGENCY / MEDICAL CLAUSE

- Photographer may contact emergency services if Client is unable to do so
- Client authorizes Photographer to seek reasonable medical assistance if necessary
- Client releases Photographer from liability for good-faith emergency actions

Client remains responsible for any medical expenses incurred.

9. INDEMNIFICATION CLAUSE

Client agrees to indemnify and hold harmless Photographer and Sergei Fadeev from claims arising from:

- Client's actions or failure to follow safety guidance
- Accidents, slips, falls, or injuries
- Third-party claims resulting from Client's conduct

10. PHOTOGRAPHY STYLE / DIRECTION DISCLAIMER

Client acknowledges that Photographer may provide creative direction, pose guidance, and artistic instruction throughout the session.

Participation in any pose is voluntary, and Client agrees to communicate discomfort immediately.

Photographer may modify or discontinue any pose or activity if Photographer determines it may present a safety risk or exceed Client's physical capabilities.

11. RELEASE OF LIABILITY

Client releases and holds harmless Valeriia Guznenkova, her business, and Sergei Fadeev from claims related to:

- Personal injury
- Property damage
- Slipping, falling, fainting
- Use of props, furniture, or elevated surfaces
- Oil application or studio conditions
- BTS videographer presence when service is selected

including claims arising from ordinary negligence. This release does not apply in cases of gross negligence or willful misconduct.

12. CLIENT RESPONSIBILITY

Client agrees to:

- Disclose injuries, allergies, pregnancy, or relevant medical conditions
- Arrive hydrated and nourished
- Avoid intentionally restricting breathing
- Communicate discomfort immediately
- Exercise personal judgment regarding poses
- Immediately communicate any pain, dizziness, numbness, tingling, weakness, injury, or physical limitation that may affect participation
- Take responsibility for maintaining adequate hydration, nutrition, and physical well-being before and during the session

13. NO GUARANTEE OF PHYSICAL OUTCOME

Client understands that participation may result in temporary physical effects, including but not limited to:

- Muscle soreness

- Lower back strain
- Nerve pinching or compression
- Temporary numbness or tingling caused by prolonged positioning.
- Muscle spasms
- Neck, shoulder, hip, knee, or wrist discomfort
- Minor sprains
- Temporary redness or skin irritation
- Physical fatigue

Client acknowledges that certain poses may place stress on the lower back, hips, knees, or other joints and agrees to communicate discomfort immediately.

14. AGE CONFIRMATION

Client confirms they are at least eighteen (18) years of age at the time of signing this waiver.

15. ENTIRE AGREEMENT

This is a standalone liability waiver separate from any contract or model release.
